- b. <u>James A. Noe ROTC Armory HVAC Replacement</u> Northwestern State University \$385,000

FY 2012-2013 CAPITAL OUTLAY BUDGET RECOMMENDATION STATUS REPORT

Staff reported on the status of the FY 2012-2013 Capital Outlay Budget Recommendation approved by the Facilities and Property Committee and Board of Regents last October. House Bill No. 2, the capital outlay bill, which includes the recommendations of the administration, has been introduced but remains to be heard by the first of seven legislative committees. Staff indicated that it appears, as has been the case for several years, that the administration supports completing projects that were in progress, but is initiating very few new projects.

No action was necessary by the Facilities and Property Committee.

LEASE

Staff presented a request for consideration of a lease from the Louisiana State University System for the purpose of making improvements to the band and choir areas of the Laboratory School at Louisiana State University and A&M College. The lease, between the LSU Board of Supervisors and the LSU Property Foundation, provides for layout changes and improvements to finishes and is essentially a second phase to a previously approved project. The work, estimated to cost \$333,330 and utilizing a total construction budget of \$400,000, will be funded from private donations. Under the terms of the lease, the premises will be leased to the LSU Property Foundation who will, in coordination with the University, develop the concept and carry out the construction. Upon completion of the work, the improvements will be donated to the university and the lease will terminate. A maintenance reserve account (MRA) in the amount of 10% of the cost of construction will be provided.

The senior staff recommended approval of the proposed lease for the improvements to the band and choir area of the Laboratory School at LSU and A&M College.

On motion of Regent Martin, seconded by Regent Rasberry, the Facilities and Property Committee unanimously recommends that the Board of Regents approve the lease between the Louisiana State University Board of Supervisors and the LSU Property Foundation for the construction of improvements to the band and choir areas at the Laboratory School at Louisiana State University and A&M College.
